IMPORTANT BOUNDARY INFORMATION

Dear Belle River District High, Essex District High, Riverside Secondary, AV Graham, DM Eagle, Victoria, Lakeshore Discovery, McCallum and Maidstone School Parents and Caregivers:

At the Public Board meeting held on Wednesday, June 16, 2010, trustees approved the boundary for the secondary panel of the new school to be built on Shields Drive in Tecumseh. Maps outlining the new boundaries are available in your school and on your school's website. Maps may also be found on the board website at www.publicboard.ca under the PARC icon in the Tecumseh school area. A narrative of the boundary is attached.

As of September 1, 2011, students from A.V. Graham School (D.M. Eagle and Victoria) will no longer transition to grade 9 at Belle River District High School but will attend secondary school at the new school in Tecumseh. Students attending Belle River District High, Essex District High and Riverside Secondary schools prior to September 2011, will be allowed to complete their secondary education at the respective school.

Please note that these changes and boundary adjustments are effective **September 1, 2011.**

Recommendations:

After analyzing possible school boundary scenarios and accompanying data, it is recommended:

1. THAT THE BOUNDARY PROPOSAL FOR THE SECONDARY PANEL OF THE NEW SCHOOL IN TECUMSEH BE APPROVED:

The proposed attendance areas for the French Immersion program at the new secondary school in Tecumseh, using geographic landmarks, would be the following:

North:

Lake St Clair from proposed Lublin Ave east to Wallace Line Rd

East:

Wallace Line Rd south to County Rd 42, south along Lakeshore Rd 107, south to North Rear Rd. Pleasant Park Side Rd south to County Rd 46 to Naylor Side Rd (County Rd 23), south to the municipal boundary between Essex & Kingsville, south to Gesto Rd (County Rd 12).

South:

Gesto Side Rd (County Rd 12) from Arner Townline Rd (County Rd 23) west to Walker Rd (County Rd 11)

West:

Walker Rd (County Rd 11) north to County Rd 8. East along County Rd 8 to ERCA Greenway (abandoned railway) north to the former Windsor municipal boundary, following this boundary north of the airport lands east to Jefferson Blvd. North along Jefferson Blvd to Tecumseh Rd E. East along Tecumseh Rd E to Little River (river), north to McHugh St. From McHugh St to Aspenshore Ave, north to the proposed Jerome St, east to proposed Lublin Ave. north to Lake St Clair.

In further defining the boundaries for the English program at the new secondary school in Tecumseh, and by using geographic landmarks, the proposed attendance area would be the following:

North:

Lake St Clair between the Windsor-Tecumseh municipal boundary to the west and Wallace Line Rd to the east.

East:

Wallace Line Rd south to County Rd 42 to Lakeshore Rd 107 south to Hwy 401.

South:

Hwy 401 west to County Rd 17 (Concession 10 Rd), south to County Rd 46, west to Sexton Side Rd, south to Hwy 3 west to the ERCA greenway.

West:

ERCA Greenway (abandoned railway) north to the former Windsor municipal boundary, following this boundary north of the airport lands east to Banwell Rd, north along the municipal boundary between Windsor & Tecumseh north to Lake St Clair.

2. THAT THE SCHOOL WILL OPEN WITH GRADE 9 STUDENTS ONLY.

3. THAT ELEMENTARY SCHOOLS IN THE MUNICIPALITY OF TECUMSEH, THAT IS, A.V. GRAHAM, (D.M. EAGLE AND VICTORIA), TECUMSEH SCHOOL - ELEMENTARY PANEL WILL BECOME FEEDER SCHOOLS FOR TECUMSEH SCHOOL, SECONDARY PANEL, THEREBY CREATING A TECUMSEH FAMILY OF SCHOOLS.

4. THAT THE BOUNDARY FOR BELLE RIVER DISTRICT HIGH SCHOOL BE ADJUSTED

AS:

North:

Lake St Clair between Wallace Line Rd east to Chatham-Kent municipal boundary

East:

Chatham-Kent municipal boundary from Lake St Clair south to County Rd 8

South:

County Rd 8 from Chatham-Kent municipal boundary west to Rochester Townline Rd, then down the centre line of County Rd 8 west to Lakeshore Rd 229. North along Lakeshore Rd 229 to South Middle Rd. West along South Middle Rd to County Rd 27 (Belle River Rd). North to County Rd 27 to Hwy 401. West along 401 to Lakeshore Rd 107.

West:

Lakeshore Rd 107 from Hwy 401 north to County Rd 42, then along Wallace Line Rd north to Lake St Clair.

5. THAT THE BOUNDARY FOR ESSEX DISTRICT HIGH SCHOOL BE ADJUSTED AS:

North:

From ERCA Greenway & Hwy 3 east to Sexton Side Rd to County Rd 46 to County Rd 17 (Concession 10) north to Hwy 401. East along 401 to County Rd 27 (Belle River Rd).

East:

County Rd 27 (Belle River Rd) from 401 south to South Middle Rd. East along South Middle Rd to Lakeshore Rd 229, then south along Lakeshore Rd 229 to County Rd 8, then east to County Rd 31 (Albuna Townline Rd) South along County Rd 31 to Road 6 E.

South:

Road 6 E to west to North Talbot Rd to Inman Side Rd. Along Inman Side Rd west to Hwy 3, then west to Road 6 W, then west to County Rd 23 (Arner Townline Rd). South along County Rd 23 to County Rd 18 (Concession 7). West along County Rd 18 to Walker Rd.

West:

Walker Rd north to County Rd 8. County Rd 8 east to the ERCA Greenway then north to Hwy 3.
